There are no spectators at Playa del Fuego; everyone collaborates in some way to create the event. It's a place for radical self-expression, acceptance, inclusivity, and respect. Unfortunately due to COVID we had to cancel our event for 2021. We instead held a virtual event where we did give out grants.
