There are no spectators at Playa del Fuego; everyone collaborates in some way to create the event. It's a place for radical self-expression, acceptance, inclusivity, and respect. Unfortunately due to COVID we had to cancel our event for 2020 and in turn did not give out any grants. Any sales were given the option for a refund or to carry over their tickets to the next event.
