Event Planning - Constellation (Aye, Cramer):

- General update
 - Things are going well
- Budget
- Work Weekend
 - o This weekend Aug 18 20
 - o Who's going? Smiles, Aye, Whatever, Hatter
 - o There will be another one in September, tentatively 22-24
- Ticketing
 - Sale Dates
 - Round 1 ticket sale July 9, 2023
 - First round sold out (480 tickets)
 - Round 2 ticket sale Jul 13, 2023
 - 439 Sold so far
 - Tickets and Cost
 - Each round has 480 tickets at \$100 each
 - Car passes: \$25 (mandatory for all cars)
 - RV Passes: \$50 (mandatory for all RVs, limited spots, no hookup access on site)
 - Ice 7lb bags: \$5

 - Tovia volunteered to reach out but can't do so until after Burning Man. Smiles may do so as well
 - Aye and Whatever will have to help a bit
 - Can ask the landowners for some more clarity on what they're looking for at the August work weekend

 - Wax has reached out to the ranger lead via email but we haven't heard back from them

Finance and Governance (Dave, Miles, Whatever Lotus):

 - Aye is now a voting member of F&G
 - Official address has been voted on by the committee, a registered agent will be used
 - \$500 to be used annually in order to do so, we estimate only \$100 should be used annually
 - Moving our bank from Wells Fargo to another bank that is more friendly to non profit organizations
 - We do have to report to the Burning Man organization as a sanctioned regional event
 - They require an afterburn report for each event
 - We do an annual report for our own transparency
 - Needed: a safety/ranger report to be written Lotus and Wax?
 - We also need to finish the board retreat report

 - We can help maintain the land we're in agreement with
 - What ways can we give back to the community?
 - Everyone should think over on this
 - We can be more affordable as an event with this
 - There may be an overlap with CACE with this shift
- Miles would like to be the main point of contact with landowners along with Ruby from a legal standpoint
